Howl-O-Ween Attendee Agreement and Waiver

I agree to the following terms:

- 1. I agree to practice responsible pet ownership.
- 2. I understand that Beeville Animal Control and the City of Beeville is a litter free event and agree to immediately deposit trash or dog waste in the proper receptacle.
- 3. I do hereby agree and warrant and am able to provide proof that my dog has complete, up to date vaccinations and current rabies shots.
- 4. I agree not to leave my dog unattended at any time.
- 5. I release any right and grant Beeville Animal Control and the City of Beeville to use, without payment, any pictures, videos, motion pictures, sound recording, or other information derived from Howl-O-Ween.
- 6. By participating in Howl-O-Ween, I recognize that injury, illness, or damage could occur to my person, children, property, or pet caused by any of the participating pets, participants, premises or property defects, or other causes.
- 7. I, for myself and all others who might otherwise make claim on behalf of myself, do hereby assume full and sole responsibility for any injury, illness, or damage, accidental or intentional, which may occur to myself, children, property or pets directly or indirectly as a result of or during my participation in Howl-O-Ween.

Code of Conduct:

The first concern of all staff is the safety of our patrons. To maintain the highest level of safety, we request that all Participants abide by the code of conduct set below:

- 1. Children under the age of 8 must be accompanied and supervised by a person 16 years of age or older. ALL CHILDREN UNDER THE AGE OF 7 MUST REMAIN WITHIN ARMS REACH OF A PARENT OR GUARDIAN AT ALL TIMES.
- 2. Admission to the facility may be denied for any of the following reasons:
 - a. Suspicion that a human participant is under the influence of alcohol or drugs.
 - b. Evidence that an animal participant has a contagious disease or open wound.
- 3. Abusive or profane language will not be tolerated. You may be asked to leave.
- 4. Cigarettes, chewing tobacco, or alcoholic beverages are prohibited inside the facility.
- 5. No glass containers or alcoholic beverages are allowed on premises.
- 6. Running, fighting, rough play, pushing and shoving are not allowed.
- 7. All owners and animals must obey the rules and regulations listed above and follow the instructions of City of Beeville Staff and Volunteers.
- 8. Any City employee will expel any person from the property for violation of rules or for any other action detrimental to the safety of others or operations of the facility. In case of serious misconduct, the City of Beeville Police Department will be called.

I fully understand and agree that failure to comply with any and all obligation outlined in this Howl-O-Ween Attendee Agreement and Waiver, will result in my and my pet's removal from the facility.
