### **Notice of Adopted 2023 Tax Rate**

THE CITY OF BEEVILLE ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 22.07 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$10.59.

**Notice of Adopted 2018 Tax Rate**

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 18.39 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$74.16

**Notice of Adopted 2017 Tax Rate**

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.81 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$27.90

**Notice of Adopted 2016 Tax Rate**

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 9.51 PERCENT.

**Notice of Adopted 2015 Tax Rate**

City of Beeville ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 1.87 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$96.25.
